



Our Vision: World Class Public Transport

- Fleet decarbonisation, to reduce carbon emissions
- Improved customer experience, across the entire network
- Increase mode shift towards 40% share of PT/ active transport



We have planned to spend \$2.5 Billion on public transport over the next 10 years. Around \$2 billion will be spent on capital and it will take \$500 million to pay for operating costs and to renew our assets.

Funding comes from several sources including central Government, fares, and rates




