The Wellington City District Plan



As we meet for our Annual Meeting this year, the densification of Wellington City is has finally completed its process of going through Council. Some matters still remain under the full RMA process, but these do not affect zoning and building rules.

The Independent Hearings Panel (IHP) completed the fast track process and made its report to Council in February. During several streams of Hearings, Lawrence and Julie Ward made four presentations on behalf of our community, expanding on the written presentations we made the year before.

Our principal goal was to avoid other submitters re-litigating the Johnsonville Train Line as a Rapid Transit System, as this would lead to High Rise Development in Khandallah.







We had to come up to speed with the RMA process for the District Plan very quickly. However we succeeded in achieving our principal goals, using three independent experts to support our case in partnership with the Wellington Character Charitable Trust. We achieved the following:

- 1. The Commissioners established as a matter of fact that the Johnsonville Rail Line was not a Rapid Transit System and accepted key points from our evidence to this effect,
- 2. The Commissioners kept the 1.5m front setbacks and 1m side setbacks for medium density housing, which Council Officials had also supported,
- 3. The Commissioners rejected the concept of City Outcomes that would have enabled Local Centre and Medium Density heights to be increased without resource consent.

Council met last week to review the IHP modifications to the Proposed District Plan. The dominant left block voted for a few significant changes to the Plan, which have been exaggerated as a "generational change". As you will be aware from my email yesterday, these included using Kāinga Ora and Stride qualitative submissions to amend the Johnsonville Train Line to be a Rapid Transit System, completely ignoring the expert evidence of Waka Kotahi and the detailed analysis of the Commissioners. Rebecca Matthews also pressed a motion to remove the front and side setbacks from medium density housing. So Khandallah has a 22m height zone within a 10-minute walking catchment of our three stops on the Johnsonville Train Line. I sent you the amended zone maps.

The matter is now in the hands of Chris Bishop, the Minister for Housing. He must decide whether to accept the Council amendments or keep the IHP recommendations for the issues voted on last week, all of which carried despite the best efforts of other councillors, including Diane Calvert and Ray Chung.

Community emergency preparedness - November 2023

In November we held our community resilience summit in Khandallah Town Hall jointly with the Wellington Region Emergency Management Office. Many thanks to Martin Jenkins and Heather McCaskill for helping to organise this. The summit identified the issues that we can expect if we have a significant earthquake or flood event of the magnitude of Cyclone Gabrielle — which a year later is still badly affecting rural communities. The impact of these is expected to deprive us of any external support from emergency services for at least a week. This covers services such as the following:

- 1. 3-waters services will be broken replacement fresh water will take time to set up
- 2. Electricity expect to be cut off for an extended period
- 3. Communications cell towers stop operating when their back up power runs out
- 4. Road access will be cut off
- 5. Food supermarkets cannot operate without electrical power, or deliveries
- 6. Healthcare pharmacy, general practice and hospital access all unavailable initially
- 7. Shelter many houses will be uninhabitable.

This means that we must prepare for such an event by firstly ensuring our own household resilience: water storage, emergency toilets, emergency food and cooking facilities (eg bbq), a battery radio, adequate supply of prescription drugs, cash to buy food or other essentials, etc., etc. The next step in 2024 is to define what our community resilience looks like when our household resilience runs out.





Road safety Expo - July 2023

In July we held a Road safety Expo to explore how we can stay safe on our roads. Many thanks for Martin Jenkins for organising this. Five guest speakers addressed the following topics:

- 1. Understanding driver behaviour Peter Sheppard
- 2. Intersection safety Zackary Moody, WCC
- 3. Speed management Ash Williams, NZ Police
- 4. Cyclist safety Jonathan Kennett
- 5. Drowsy driving Martin Jenkins

One of the most dangerous things we can do is to assume we know all we need to know; I certainly did not. Peter gave us some great safe driving tips, Zackery took away several suggestions for improving our road intersections, Ash reminded us of the fundamentals through insights into how essential they are, Jonathan talked about how to get down to the City safely, and Martin highlighted one of the worst enemies of road safety – microsleeps while driving.

Christmas Party 2023

Once again we aimed to celebrate Christmas and the end of another year at two events: The Khandallah Fair (organised by the Lions) and our own Christmas Party upstairs in the Khandallah Town Hall. Regrettably the Khandallah Fair was had to be a much smaller affair held in the Town Hall due to weather, so we skipped it. However our party was a great celebration of another ORCA year where we put our community first.
